Additional funding has been allocated to enhance the High Street pedestrian zone and improve public spaces.

## Getting Here

- ▶ Situated in the heart of Kirkcaldy, approximately 12 miles from Edinburgh and 28 miles from Dundee.
- ▶ 3 multi-storey car parks with 900 spaces adjacent to the centre at Tolbooth Street, Thistle Street and the Esplanade.
- ▶ 10 minute walk from the train station, with regular taxi service.
- ▶ Mercat Shopping Centre is a short walk from Kirkcaldy bus station.

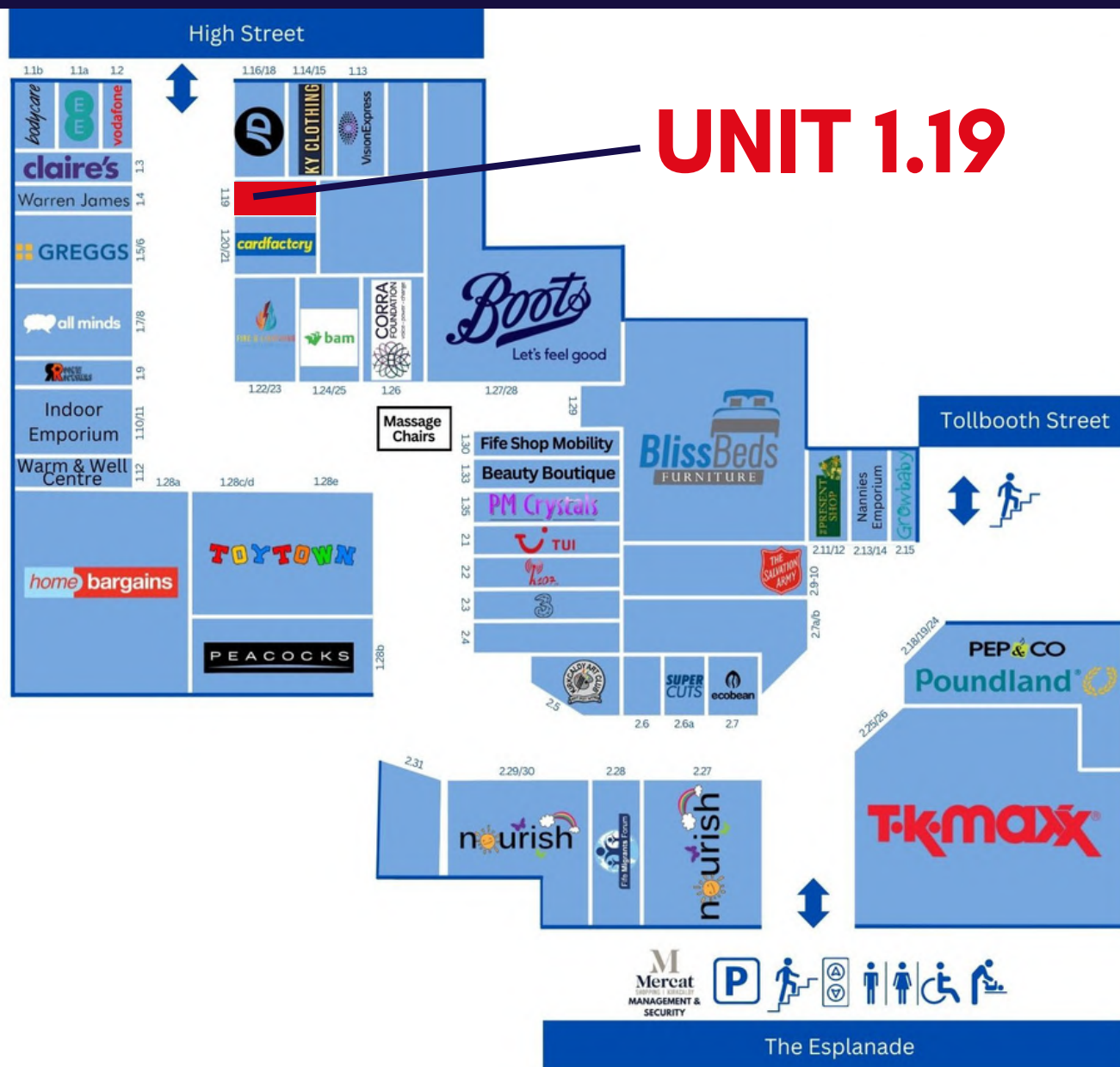

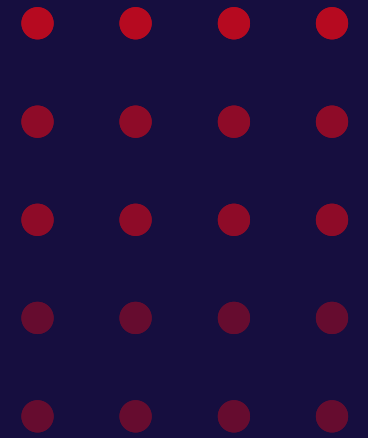
## AGENTS NOTES
